Subject: Transportation Improvement Program (TIP) amendments

Action Requested: Approval of Formal TIP Amendment 26-01

Since the committee's last meeting, project programmers submitted 96 formal amendments for Transportation Committee consideration. Additionally, 144 administrative amendments were submitted, reviewed, and accepted by staff. Summary information is presented below. Formal Amendment 26-01

Formal Amendment 26-01 includes 96 projects that have been submitted for Transportation Committee approval. Projects with cost changes above the administrative thresholds (23) added \$76.4M in total cost and \$40.2M in federal participation. New projects (23) added \$68.1M in total cost and \$48.5M in federal participation. Projects (50) with phases moving into or out active TIP years (FFY 25-29) reduced total cost by \$0.3M and increased federal participation by \$1.2M. The overall change in total project cost within all prior, current, and future years from this amendment is \$144.2M in total cost, and \$89.9M in federal participation, as shown in the table below.

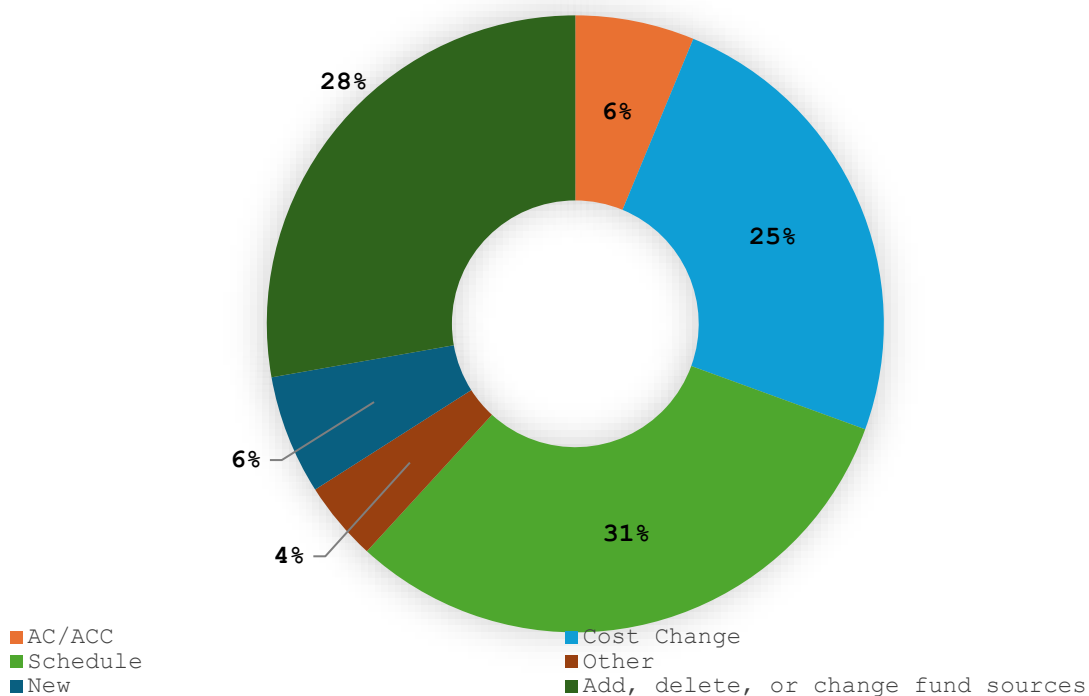

Administrative Amendments 26-01.1 and 26-01.2

A total of 144 Administrative Amendments were submitted, reviewed, and accepted by staff on amendments 26-01.1 and 26-01.2. Administrative amendments include new projects that are not federally funded or have all federal funds in future years, conversion of project phases to or from Advance Construction (AC), cost changes that are below CMAP's amendment thresholds, changes to project schedules within the years of the TIP, changes to fund sources, and other miscellaneous changes that do not affect the scope, schedule, or funding of projects in a way that requires committee approval.

26-01.1 & 26-01.2 Administrative Amendments - Type of Changes



The most frequent administrative changes are projects with schedule changes (45) that reduced total cost by \$1.7M and increased federal participation by \$0.8M. Projects that added, deleted, or changed funds sources (40) reduced total cost by \$5.5M and federal participation by \$276.6M. Cost changes below the formal thresholds (35) added \$51.7M in total cost and \$4.3M in federal participation. Projects with phases going into or out of advanced construction (AC/ACCP) status (9) reduced total cost by \$0.5M and had no change in federal participation. New projects (9) added \$13.8M in total cost with no federal participation. There were 6 projects with other changes, such as the addition of project IDs or updating project location information, which did not change the total cost or federal participation. The overall result of the administrative changes was an increase of \$57.8M in total cost and a reduction of \$271.5M in federal participation.

Total cost includes all fund sources and all project phases in prior, current, and future years of the TIP. Federal participation includes only federal fund sources for all project phases in prior,

current, and future years of the TIP. The type of change, number of projects affected, total project cost, and federal project participation information is shown in the table below.
