Russell Pietrowiak, CMAP, presented the committee with the latest formal and administrative TIP amendments. There were a number of new ITEP projects added to the TIP, including pedestrian facilities, streetscapes, and bicycle trails. Audrey Wennink of MPC posed questions about the TIP process, administrative thresholds and how CMAP evaluates the justification of cost increases. She expressed an interest in an analysis of efficiency of project cost changes. Wennink also questioned whether the committee can approve or deny projects on an individual basis. Pietrowiak indicated that amendments do not always entail a cost change but instead, funding is moved around and adjusted. The project sponsor is responsible for justification for cost changes. He also responded that the matter of Transportation Committee authority is more of an issue of committee policy. John Donovan of FHWA added that TIP authority is granted from MPO policy committee. Jack Cruikshank of IDOT asked about the ramifications on conformity if an individual project change is denied by the committee. Tara Orbon of Cook County added that there are checks in place through the Councils of Mayors and Planning Liaisons. Bob Dean of CNT asked if there is value in flagging projects that have changed significantly. Henry Guerriero added that he feels the obligation report, the TIP and all amendments to the TIP should be viewed in conjunction with the amendment report. There is interest in further discussions about the

TIP process.

5.1 Plan of Action for Regional Transit (PART) report update

PURPOSE: Update of CMAP's ongoing work to develop a transit system report, the Plan of Action for Regional Transit (PART), required by the Illinois General Assembly.

ACTION REQUESTED: Information

Laura Wilkison, CMAP, updated the committee on PART progress with the service boards. CMAP staff focused on finalizing the system improvements, the options being considered for funding and revenue. Governance is an additional topic being addressed with this report. CMAP is working to create a framework of governance built from a problem statement. The PART update also included presentations on efficiencies and service changes by CTA, Pace, and Metra staff. In this, staff is looking to maximize the budget as it relates to service. Kyle Whitehead of RTA urged the committee to consider the imminence of the fiscal cliff. Audrey Wennink of MPC emphasized the need for state involvement in transit. Jack Cruikshank of IDOT discussed automatic enforcement and the localization of those funds. CMAP staff plan on holding 1-on-1 conversations with all of the Board and MPO members in coming months. Henry Guerriero of the Tollway added that drivers are already price incentivized to take transit and increasing toll rates could risk freight and manufacturing jobs. Christina Kupkowski of Will County expressed that more rural areas are concerned about paying for transit services that we they don't have access to.

6.0 Legislative Update

John Carpenter and Kasia Hart, CMAP, gave an update on their meetings with leaders in Springfield. The Illinois House has approved the annual 2024 budget. House Bill 1342 was included in the session as an omnibus transit bill including changes to safety enforcement, procurement of new bus fleets, service board performance measure, and an RTA study on year-round free and reduced fares. A bill to require employers to provide pre-tax transit benefits could be brought forth. The committee discussed concern about HB 2878, which included language regarding the MPO's long range transportation planning and the role of the MPO in the P3 process. Bob Dean of CNT echoed concerns about this bill and its link to HJR23. Audrey Wennink of MPC and Kyle Whitehead of RTA added concern about expansion of I-55 and the potential to get this project removed from CMAP's long range plan.

7.0 Other Business

Leah Mooney of CTA revisited the ideas from the PART presentation and concerns about regional access to transit, adding that she believes more conversations with committee members would be good. Mooney raised concerns about the economic impacts of removing transit and increasing congestion in Chicago. Jack Cruikshank of IDOT asked about the status of committee working groups. Aimee Lee stated that it's been tabled since the return to in-person meetings.

8.0 Public Comment

Garland Armstrong, a member of the disability community and former resident of the region, questioned whether the Elmhurst Metra station has made progress in terms of access to people with disabilities when switching platforms are there is currently only stairs between them. He emphasized that there are not enough safety measures in place on CTA trains and platforms. He also praised PACE and CTA's efforts to create transit solutions for non-standard working hours. Armstrong urged the committee to ensure that ADA is a consideration when looking at the transit fiscal cliff.

9.0 Next Meeting

The next meeting is scheduled for Friday, July 28, 2023.

10.0 Adjournment

Since the committee's last meeting, project programmers submitted 48 formal amendments for Transportation Committee consideration. Additionally, 223 administrative amendments were submitted, reviewed, and accepted by staff. Summary information is presented below. A list of projects and report of the full change details for each amendment are available on the Amendments tab of the eTIP public web page. Fiscal constraint has been reviewed with consideration of both formal and administrative changes and the TIP will remain fiscally constrained if the formal amendments are approved. Staff therefore requests committee approval of Formal Amendment 23-10.

Formal Amendment 23-10


A total of 48 formal amendments were submitted for Transportation Committee approval on amendment 23-10. Cost changes that exceeded the threshold for administrative approval made on 27 projects resulted in \$145.1 million in total cost being added to the TIP, with an additional \$93.4 million in federal participation. Fourteen (14) new projects with a total cost of \$21.4 million and federal participation of \$17.7 million were added to the TIP. One (1) project was deleted from the TIP, removing less than \$200,000 from the TIP. Schedule changes resulted in six (6) projects having phases moved into or out of the current years (2023 – 2027) of the TIP. Cost adjustments with these changes added \$40.2 million to the TIP. The overall change in total project cost within all prior, current, and future years due to this amendment is the addition of \$206.6 million in total cost, and \$136.4 million in federal participation, as summarized below.



Administrative Amendments 23-10.1 and 23-10.2

A total of 223 Administrative Amendments were submitted, reviewed, and accepted by staff on amendments 23-10.1 and 23-10.2. Administrative amendments include new projects that are not federally funded or have all federal funds in future years, conversion of project phases to or from Advance Construction (AC), cost changes that are below CMAP's amendment thresholds, changes to project schedules within the years of the TIP, changes to fund sources, and other miscellaneous changes that do not affect the scope, schedule, or funding of projects in a way that requires committee approval.





Having completed review of June quarterly status updates for locally programmed STP, CMAQ, CRRSAA, and TAP projects, most of the administrative changes (75) were schedule changes that did not add or remove funding from the TIP. Sixty-four (64) changes were made to either place funding into Advance Construction (AC) status or convert funding from AC status (ACC). Cost adjustments made with these changes added about \$8.6 million in total cost to the TIP. Thirty-eight (38) projects submitted cost changes, adding \$9.6 million in total cost to the TIP, but reducing federal participation by \$5.4 million. Three (30) new projects totaling just under \$40 million, most from IDOT's recently released MYP, were added to the TIP administratively. These new projects contain \$25.5 million in federal participation that is planned for years beyond the current years of the TIP. A modest \$2.3 million was removed from the TIP with the

deletion or completion of four (4) projects. Finally, twelve (12) other non-financial changes, including adding project IDs and making minor limit or descriptive changes, were made. In total, \$55.5 million in total cost was added to the TIP administratively, and federal participation increased by \$22.1 million. The type of change, number of projects affected, total project cost, and federal project cost information is shown in the table below. Total cost includes all fund sources and all project phases in prior, current, and future years of the TIP. Federal cost includes only federal fund sources for all project phases in prior, current, and future years of the TIP.

- Purpose: On July 13, 2023, the Project Selection Committees for STP and CMAQ/CRP/TAP-L met and discussed the staff recommended programs for the FFY 2024-2028 Congestion Mitigation and Air Quality Improvement (CMAQ), Carbon Reduction (CRP), locally programmed Transportation Alternatives (TAP-L) and STP Shared Fund regional transportation funding programs. The Project Selection Committees released the program recommendations for a Public Comment Period from July 13 to August 11, 2023.

Action Requested: Information

A joint call for projects was issued in January 2023 for the FFY 2024 – 2028 Surface Transportation Program (STP) Shared Fund, FFY 2024 - 2028 Congestion Mitigation and Air Quality Improvement (CMAQ) program, Carbon Reduction Program (CRP) and Transportation Alternatives Program (TAP-L). A total of 129 applications were received across all four funding programs. Staff evaluated the applications according to the methodologies approved by the respective project selection committees (PSCs) contained in the application booklets published with the call for projects to determine eligibility for funding and final scores. Staff then developed recommended programs of projects to be funded with each fund source. These programs were reviewed by the PSCs on July 13, 2023 and released for public comment through August 11, 2023.

This memo contains an overview of the draft recommended programs and links to detailed documentation for the committee's information. Committee members are encouraged to discuss the proposed programs within their agency and submit comments to staff. Following the public comment period, the PSCs will consider comments and any recommended changes to the programs and are scheduled to consider final approval on August 31, 2023. Following PSC approvals, staff will prepare TIP amendments reflecting the approved programs for consideration by the Transportation Committee on September 22, 2023 for a recommendation that the CMAP Board and MPO Policy Committee approve the TIP amendments containing the approved programs at their joint meeting on October 11, 2023.

Combined Transportation Investments

Within the three funding programs, over \$593 million is recommended to fund more than 65 bicycle and pedestrian, bridge, emissions reduction, highway, and transit projects throughout northeastern Illinois:

The recommended programs include nearly \$335 million for 17 projects located in the region's highest need (Cohort 4) communities.

FFY 2024 – 2028 CMAQ/CRP/TAP-L Program

Ninety-one (91) unique applications (CMAQ/CRP and TAP-L) were submitted for funding consideration under the CMAQ, CRP, and TAP-L programs.

CMAQ/CRP applications were evaluated for their air quality benefits, transportation impact, and equity to develop a recommended program that includes \$399.5 million for 30 projects, of which two (2) are bicycle facilities, sixteen (16) are highway projects, and twelve (12) are transit projects. The transit projects account for 92% of the programmed funds (\$375M). Two (2) of the transit projects will be funded at 100% using Transportation Development Credits (TDCs) and four (4) projects will be funded at 100% using Transportation Development Credits -Highways (TDCHs), including one (1) project that received funding for phase 1 engineering only.

TAP-L applications were evaluated for their ability to help complete the Regional Greenways & Trails Plan as well as encourage non-motorized transportation and equity.

The recommended program includes \$93.7 million for 17 bicycle facility projects that will further completion of the Regional Greenways & Trails Plan. Five (5) of the projects will be funded at 100% using Transportation Development Credits - Highways (TDCHs), including three (3) projects that received funding for phase 1 engineering only.

FFY 2024 – 2028 STP Shared Fund Programs

Staff reviewed 60 applications for compliance with the program's eligibility rules and determined that eleven (11) ineligible projects would be eliminated from further consideration. Because shared fund applicants have the option of requesting consideration in more than one of nine (9) project type categories, staff conducted 80 evaluations of the 49 eligible projects, to determine the highest score for each project in the categories it was eligible for. During this step of the evaluation process, seven (7) projects were eliminated from consideration because they did not meet the minimum need threshold(s) in the category or categories that they requested consideration under. Details of the evaluation process are described in a memo to the STP PSC.

In addition to the ten (10) projects currently programmed in FFYs 2024 – 2026, the recommended Active Program includes \$20.2 million for cost increases for two (2) existing projects in FFY 2024, \$14.9 million for nine (9) new projects in FFYs 2025 and 2026, and \$65 million for eight (8) new projects in FFYs 2027 and 2028. \$40 million is recommended for two (2) projects located within the City of Chicago, \$33.6 million for nine (9) projects within suburban Cook County, and \$26.5 million for eight (8) within the collar counties. Over \$20 million is proposed for six (6) projects in communities with the highest need (Cohort 4), including \$1.7 million in Transportation Development Credits and \$4.8 million for phase 1 engineering only. One-third of the projects recommended (7 of 19) are within municipalities with populations of less than 25,000. The facilities selected serve over 19.7 million jobs and households combined. More than one-third of the projects improve facilities where more than 10% of the users are minorities below the poverty line. All recommended projects include complete streets elements or are within jurisdictions with complete streets policies. Of the projects evaluated for resilience, three (3) of seventeen (17) have policies in place, and thirteen (13) included resilience elements in the project scope. Eight (8) of the sixteen (16) projects

evaluated for freight impacts are within jurisdictions with freight supportive policies and procedures and six (6) projects are located on a regional freight network.

All eligible projects that applied for the STP Shared Fund that were not recommended for full funding through the Shared Fund, CMAQ, CRP, TAP-L or other programs (such as ITEP and RAISE) are recommended by staff for inclusion in the staff recommended Contingency Program, where they may be considered for funding that becomes available through September 30, 2025 according to the region's Active Program Management policies. Next Steps

Following the public comment period (July 13 through August 11, 2023), staff will present a summary of comments and any recommended changes to the programs to the respective PSCs on August 31, 2023. Upon approval of final programs by those committees, TIP amendments will be prepared for consideration by the Transportation Committee on September 22, 2023 for a recommendation that the CMAP Board and MPO Policy Committee approve the TIP amendments containing the approved programs at their joint meeting on October 11, 2023.
