For calendar year 2025, staff has recommended that Cassaundra Rouse, Executive Director of the Illinois Tollway, serve as vice-chair.

A motion was made by CoM Representative Jeff Schielke, seconded by McHenry Co Representative Scott Hennings, to nominate Cassaundra Rouse, Executive Director of the Illinois Tollway, to the MPO Policy Committee for the vice-chair position for calendar year 2025.

A motion was made by RTA Representative Kyle Whitehead to nominate Jim Derwinski, Chief Executive Officer and Executive Director of Metra, to the MPO Policy Committee for the vice-chair position for calendar year 2025. He indicated that Mr. Derwinski would be best suited to serve the MPO Policy Committee as vice-chair due to Metra's ongoing transition to a regional rail model and his leadership as transit agencies face a financial fiscal cliff.

Discussion ensued regarding the need to ensure there is need for someone who can demonstrate impartiality related to the programming of federal funds, the need for someone to understand what transit agencies are experiencing, and the need to have a balanced representation of vice-chairs.

## Purpose

Per the MPO Policy Committee By-Laws, "each year during June, after notice to the membership in the call and agenda of a particular meeting, the Chair shall appoint a subcommittee of five members of the MPO Policy Committee to nominate at a meeting in October, the name or names of candidates for election to the office of Vice-Chair of the MPO Policy Committee for the following year."

Past practice has been that the Vice-Chair serves two consecutive terms. Cassaundra Rouse, executive director, Illinois Tollway, was appointed to serve as Vice-Chair for the calendar year 2025. Staff recommends that Cassaundra Rouse be reappointed to serve as the MPO Policy Committee Vice-Chair for the calendar year 2026.
