Martha Trotter, Sikich, LLC, presented the preliminary FY 2021 Financial Audit to the Committee. Based on their audit, CMAP has received a clean, or unmodified, opinion, the highest level an opinion that Sikich can provide. The report includes the single audit which pertains to CMAP's grant activity. There were no instances identified of noncompliance or significant deficiency.

Executive Director Aleman reported that this item will be brought to the CMAP Board in February.

The FY 2021 financial audit was received and referred to the CMAP Board for their February 9, 2022 meeting.

#### 6.02 Local dues contributions

<u>22-014</u>

Erin Aleman reported that CMAP has received much of its federal match from the state. In 2016, the agency implemented a local dues program. With the influx of additional federal funding through the Infrastructure Investment and Jobs Act (IIJA) now known as the Bipartisan Infrastructure Law (BIL), there is a need to increase local dues in the future to meet the required local match funding requirements. Director Aleman noted that the state has agreed to match the local match this year. Discussion ensued regarding next steps.

Director Aleman will work with staff on next steps and will bring this issue back to committee and the CMAP Board for further discussion and consideration.

The committee discussed local dues contributions.
