Executive Director Erin Aleman reported on the Infrastructure Investment and Jobs Act (IIJA) Priority Booklets, the proposed budget and work plan, the federal and state Advocacy Agenda, the Plan of Action for Regional Transit (PART), and the recent visit of Vice-President Kamala Harris for the announcement of IIJA bridge funding for the City of Chicago's Calumet River Bridges.

Executive Director Aleman reported on the convening of an advisory group from the Transportation Committee for the review of the current project selection subcommittees and the discussion of potential process improvements and alignments. The Transportation Committee discussed the proposed timeline and scope for the project at its last meeting.

Staff will continue to meet with the advisory group and the Transportation Committee to create bylaws for the Transportation Committee's subcommittees, build stronger information sharing pathways, conduct peer exchanges with other metropolitan planning organizations (MPOs), and recommend process improvements to the Transportation Committee for the UWP Committee and possibly other subcommittees. Staff will keep MPO Policy Committee informed throughout the process.

# 5.02 Roadway Safety Performance Targets for 2023

# Attachments: Board MPO SafetyTargets 2023

Victoria Barrett, senior planner in Regional Policy and Implementation division, presented the 2023 roadway safety performance targets. The roadway safety performance measures are a part of the Federal Highway Administration's (FHWA) Transportation Performance Management (TPM) program that focuses on five traffic safety performance measures mandated since 2018.

Victoria Barrett reviewed the process for roadway safety targets, noting that the process begins with IDOT sharing its statewide roadway safety targets. The FHWA conducts an annual assessment to determine whether the state has met or made significant progress toward accomplishing its safety targets. If the state does not meet or make significant progress on four of its five safety targets, the Highway Safety Improvement Program (HSIP) apportionment funding can only be used for safety related projects in the state.

Victoria Barrett reviewed statistics on the annual rate of fatalities, fatalities per 100 million vehicle miles traveled (VMT), serious injuries, rate of serious injuries per 100 million VMT, and non-motorized fatalities and serious injuries. While the rate of serious injuries has declined, the rate of fatalities has increased within the same time frame. The state has targeted a two percent annual reduction in each

of its five safety targets.

Staff recommends supporting IDOT's 2023 roadway safety targets. CMAP has expanded the safety work with the Safe Travel for All Roadmap (STAR) program to help meet the targets and will continue to track and publicly report on regional safety performance measures and targets.

#### 6.02 2023 Federal and State Advocacy Agenda

# Attachments: CMAP AdvocacyAgenda FINAL

John Carpenter, Legislative Affairs Director, presented a draft of the 2023 Federal and State Advocacy Agenda. The combined agenda reflects the policy and legislative recommendations that will be needed to fully leverage the opportunities available to our region since the passage of the Infrastructure Investment Jobs Act (IIJA) and Climate and Equitable Jobs Act (CEJA).

The draft agenda was informed by CMAP's strategic direction and was realigned to reflect CMAP's core focus areas of transportation, regional economy, and climate.

The 2023 Federal and State Advocacy Agenda was presented.

#### 6.03 Plan of Action for Regional Transit (PART) report update

Senior Director and Policy Advisor Laura Wilkison provided an update on the Plan of Action for Regional Transit (PART). The General Assembly has mandated that CMAP look at the long-term financial viability of the operating system of transit and has requested that CMAP consider multiple factors and identify specific mechanisms in its recommendation.

CMAP has thoughtfully considered the scope of the work and has developed a project timeline to meet the deadline requirements of the General Assembly. In late January 2023, CMAP is convening the first steering committee, as identified in the legislation, and will continue to meet with them throughout the year. Staff will engage with the committees, the MPO Policy Committee, and CMAP Board on the work occurring on the PART project. The final draft of the report will come to the MPO Policy Committee and CMAP Board at their October 11, 2023, joint meeting.

CMAP has developed a public outreach and engagement strategy that will be used throughout the development of the report. The PART project will be aided by three CMAP Board advisors and one CMAP Board alternate advisor. Laura Wilkison identified the co-chairs and members of the steering committee and discussed the next steps which include interviews by Eno Center for Transportation, a public survey being sent out, draft white papers on topical issues, and ongoing coordination with RTA.

Pace Representative Melinda Metzger noted that the discussion should consider how transit agencies will factor the expense of getting to zero emissions.

An update of the PART report was provided.
