Russell Pietrowiak, CMAP, presented an overview of the formal TIP amendment 22-06 and the administrative amendments 22-06.1 and 22-06.2.

MPC Representative asked why there are roadway widenings in the TIP, which have been shown to reduce safety. IDOT responded that congestion can cause safety problems and adding capacity can improve safety, and they are working on intersection safety measures. CTA Representative said that roadway projects need to prioritize safety of people outside of cars. Lake County Representative added that aggressive driving and speeding are increasingly problematic and that they look forward to hearing from the Safety Task Force. University Representative urged post-implementation analysis of effectiveness of safety measures. CMAP Executive Director said that the Safety Task Force will present next month.

Stacy Meyers, Openlands, read public comment on the TIP aloud. Openlands urged increased focus on transit and "fix it first" approach to TIP projects and RSPs; caution on changes to I-55 proposed expansion through sensitive habitat; urged removal of outdated TIP projects on the unconstrained TIP list including Illiana Tollway, Tri-County Access Project through Hackmatack Wildlife Refuge, and FAP 420 in McHenry County. Barbara Klipp, Midwest Sustainability Group, supported Openlands comments on Tri-County Access project and identified safety concerns. Ethan Saltzberg, a citizen of northeastern Illinois, added comments about arterial widening, RSPs and suggested implementation of safety projects without the added lane mileage. Garland Armstrong, a former resident of northeastern Illinois, added support for safety projects to slow traffic, and asked about sidewalks in Tinley Park on 159th Street.

RE: **5.1: FFY 2019-2024 Transportation Improvement Program (TIP) Amendments and** Administrative Modifications

Dear Board Chair McEwan and members of the Transportation Committee:

I am Stacy Meyers, Senior Counsel, with Openlands, which was founded in 1963 to protect the natural and open spaces of northeastern Illinois and the surrounding region to ensure cleaner air and water, protect natural habitats and wildlife, and help balance and enrich our lives.

Thank you for considering our comments on proposed amendments to the region's Transportation Improvement Program.

We are glad to see the removal of the Wilmington-Peotone Road project from the roster of constrained projects. Based on the recent recommendations in the *Moving Will County* reports, which were funded and overseen by CMAP, we agree with clustering both freight and truck routing solutions to confine impacts so that TDL complements globally significant natural areas within Midewin National Tallgrass Prairie, as well as high quality natural areas such as the Des Plaines Conservation Area and Jackson Creek watershed. We see the need for caution in any approach to improving Interstate 55, in that it could seriously degrade these resources if not done consciously to protect the delicate conservation values that run against the current highway. The same is true for any improvements to Arsenal-Manhattan Road through the Joliet Training Area, which is promised to the USFS to become part of Midewin. The proposed expansion bounds the Jackson Creek Watershed, which flows into Midewin. We look forward to a study process that engages experts to ensure resources, like wet mesic dolomite prairie – one of the rarest ecosystems in the world – are protected in the process.

While today's agenda involves amendments to the existing Transportation Improvement Program, this presents an opportunity to review what is also on the unconstrained list to ensure those recommendations are still timely and relevant. We strongly urge the Transportation Committee and the Chicago Metropolitan Agency for Planning to remove three projects from that list, which are outdated, outmoded, and have been officially terminated due to court proceedings.

The first is the Illiana Tollway. Since the Illinois Department of Transportation agreed to remove this project from the State TIP after the environmental studies for the project were invalidated in federal

court, this should carry through to the regional TIP in that reference to the project should also be deleted. This would be consistent with the most recent land use and transportation planning overseen by CMAP in the *Moving Will County* project. We appreciate that the project previously was removed as a constrained Regionally Significant Project – it is now time that it is also struck from the unconstrained list.

For similar reasons, references to the Tri-County Access Project and the FAP 420, a corridor that would run a highway through the eastern part of Hackmatack National Wildlife Refuge should be removed from the unconstrained list and not included in the update to ON TO 2050. The Tri-County Access Project was cancelled by the Illinois State Toll Highway Authority, and since then, the State legislature authorized a task force to develop alternative uses for the Route 53 corridor as a greenway. Any Route 53/120 studies from decades ago are now defunct, and no longer reflective of the priorities and needs for the region. We see that the Transportation Improvement Project exists for improving Route 120 along its given path, and, similarly to our comments on Interstate 55, express that caution will need to be taken to not impact the adjacent Liberty Prairie Reserve, a planned 5,700-acre public private mosaic of natural and agricultural landscapes – over half of which have already been protected.

Similarly, the placeholder for FAP 420 in McHenry County is from decades ago, before the dedication of the Hackmatack as the first bi-State national wildlife refuge in the country. For consistency's sake, and given that the region has moved on, we respectfully request that these projects are taken off the books.

Since the June 3rd committee meeting, project programmers submitted 68 formal amendments for Transportation Committee consideration. Additionally, 194 administrative amendments were submitted, reviewed, and accepted by staff. Summary information is presented below. A list of projects and report of the full change details for each amendment are available on the Amendments tab of the **eTIP public web page**. Staff requests committee approval of Formal Amendment 22-07.

Formal Amendment 22-07


A total of 68 formal amendments were submitted for Transportation Committee approval on amendment **22-07**. Twenty-nine (29) new projects totaling \$43.4 million, with \$36.7 million in federal participation, were added to the TIP. Cost changes associated with 25 projects adding phases to or removing phases from federal fiscal years 2022 – 2026 added \$29.9 million in total cost to the TIP. Thirteen (13) other projects experienced cost changes exceeding the formal amendment thresholds, adding \$44.4 million in total cost to the TIP. One project was deleted from the TIP removing \$679,000. The overall change in total project cost within all prior, current, and future years due to this amendment is the addition of just under \$117 million in total cost and an increase of federal participation in projects by \$55.6 million, as summarized below.

Administrative Amendments 22-07.1 and 22-07.2

A total of 194 Administrative Amendments were submitted, reviewed, and accepted by staff on amendments 22-07.1 and 22-07.2. Administrative amendments include new projects that are not federally funded or have all federal funds in future years, conversion of project phases to or from Advance Construction (AC), cost changes that are below CMAP's amendment thresholds, changes to project schedules within the years of the TIP, changes to fund sources, and other miscellaneous changes that do not affect the scope, schedule, or funding of projects in a way that requires committee approval.



22-07.1 & 22-07.2 Administrative Amendments - Type of Change

The majority of administrative changes occurred when project phases were placed into (16 projects) or converted from (51 projects) Advance Construction status. Cost adjustments made with these changes resulted in the addition of \$9.2 million in total cost to the TIP. Forty-three (43) projects experienced cost changes below the thresholds for formal amendments or in years beyond the current TIP years. These changes resulted in \$63.3 million in total cost and \$9.9 million in federal participation being added to the TIP. Six (6) new projects added \$13 million in total cost. In total, \$85.5 million total was added to the TIP administratively, and federal participation increased by \$23.6 million. Three (3) projects were marked as financially complete, and schedule and other updates without any changes to cost were made on another 75 projects, primarily in response to the submittal of quarterly status updates for the region's STP, CMAQ, and Local TAP funded projects. The type of change, number of projects affected, total project cost, and federal project cost information is shown in the table on the following page. Total cost includes all fund sources and all project phases in prior, current, and future years of the TIP.
